2 SUMMARIES

2.1 **OBJECTIVE**

Extensions are components developed to customize and expand the experience in SharePoint Online. Created by development teams, they allow the behavior and interface of SharePoint to be adapted to the specific needs of the organization, adding functionalities that do not exist natively on the platform.

2.2 BRIEF DESCRIPTION OF THE PRODUCT

The Mandatory Reading Notifications for SharePoint extension was designed to ensure that organizations can deliver mandatory messages directly on their SharePoint sites. These notifications are displayed in a pop-up format when users access the site and must be read and accepted before they can access the content.

Developed in SPFx (SharePoint Framework), the extension provides administrators with a reliable and structured way to manage critical communications. All notifications are stored in a dedicated SharePoint list, while user interactions, such as reading confirmations, are recorded in a separate list. This ensures that administrators can not only deliver important messages but also track which users have viewed and accepted them.

By combining mandatory visibility with a robust logging system, Mandatory Reading Notifications for SharePoint guarantees compliance, accountability, and consistency across the organization's SharePoint environment.

3 REQUIREMENTS

For the correct functioning of the **Mandatory Reading Notifications for SharePoint**, the following requirements are necessary:

- Microsoft SharePoint Online;
- Permission level for using the web part
 - Contributor or higher (permission to add, edit records in SharePoint lists)

 - Access to the SharePoint Application Center (app catalog) to deploy extensions;

4 INSTALLATION

Follow these steps to install Mandatory Reading Notifications for SharePoint from Microsoft AppSource or the SharePoint Store:

4.1 ACCESS APPSOURCE OR THE SHAREPOINT **STORE**

Navigate to Microsoft AppSource or the SharePoint Store from your SharePoint site.

4.2 SEARCH FOR MANDATORY READING NOTIFICATIONS FOR SHAREPOINT

In the search bar, type "Mandatory Reading Notifications for SharePoint" and locate the application developed by "Torpedo – Serviços de Informática, Lda" in the search results.

4.3 ADD THE EXTENTION TO YOUR SHAREPOINT SITE

Click the extension and select **Add to Site** or **Get It Now** to add the application to your SharePoint site.

4.4 CONFIRM THE INSTALLATION

Follow the instructions to confirm the installation. You may need to grant the required permissions for the extension to function properly.

4.5 DEPLOY THE EXTENSION

After adding the extension, go to **Site Contents**, locate the **Mandatory Reading Notifications for SharePoint** application, and click on it to deploy it to your site.

4.6 ACTIVATE THE EXTENSION

After deployment, ensure that the **Mandatory Reading Notifications for SharePoint** extension is activated on your site. This may involve configuring the application settings according to your needs.

EXTENSION CONFIGURATION

5.1 **CONFIGURATION MODE**

To enter the configuration mode of the extension, simply "?usernotificationdialog=true" to the URL of the site where you want to add the notifications.

If the user has administrative permissions, the configuration menu will appear.




Figure 1 - Configuration Menu

5.2 LIST CREATION

This extension depends on two lists, **Notifications** and **UserNotifications**. Once in configuration mode, simply press the **Create Lists** button to create them.

After the list is successfully created, visitor permissions will need to be changed to account for the need to be able to add registries to the **UserNotifications** list.

5.3 CREATE PERMISSION

- 1. On the top right corner of your site, click the gear and choose **Site Permissions**. Then press **Advanced permission settings**.
- 2. On the top there will be an option **Permission Levels**.

- 3. Select the **Contribute** permission, scroll down and copy it. This will open a new page, here you will make the following changes.
 - Add the name "Add without Editing and Deleting".
 - Deselect "Edit items".
 - Deselect "Delete items".
 - Deselect "Delete Versions".
 - Add Items Add items to lists and add documents to document libraries.
 - 🗆 Edit Items Edit items in lists, edit documents in document libraries, and customize Web Part Pages in document libraries.
 - Delete Items Delete items from a list and documents from a document library.
 - View Items View items in lists and documents in document libraries.
 - ☐ Approve Items Approve a minor version of a list item or document.
 - Open Items View the source of documents with server-side file handlers.
 - ✓ View Versions View past versions of a list item or document.
 - Delete Versions Delete past versions of a list item or document.
 - ✓ Create Alerts Create alerts.
 - ☑ View Application Pages View forms, views, and application pages. Enumerate lists.

5.4 GIVING VISITORS PERMISSION

- 1. Acess your **UserNotifications** list, it is hidden by default, so you will need to navegate there using "**Lists/UserNotifications/AllItems.aspx**".
- 2. On the top right corner, click the gear and choose **List Settings**. Then go to **Permissions for this list**.
- 3. On the top left corner you will select **Stop Inheriting Permissions**. You will be prompted with a confimation, go ahead and accept.




Figure 6 - Stop Inheriting Permissions

4. Now select the **Visitor** group and press **Edit User Permissions**.




Figure 7 - Select group and edit permissions
